



Governor Chris Sununu Statement on Graham-Cassidy Healthcare Bill

On Monday, Governor Chris Sununu issued the following statement:

"While I continue to strongly believe that Obamacare must be reformed, it must be replaced with something that works for New Hampshire. The Graham-Cassidy healthcare plan has some laudable aspects, including

offering more flexibility to states in managing Medicaid. Unfortunately, under this plan, New Hampshire could possibly lose over a \$1 billion in Medicaid funding between 2020-2026. While innovative, consumer-driven programs that eliminate waste and provide flexibility is the direction our nation's health care must go, it is not practical for New Hampshire to craft a system with over \$1 billion in cuts to federal funding. New Hampshire is proud of its tradition of not having an income tax or sales tax and remains vigilant against down-shifting of costs onto states that become general fund liabilities. As such, I cannot support this plan as it is currently drafted. It is my hope that Congress will continue to improve this plan to earn New Hampshire's support. If given the opportunity, we stand ready to roll up our sleeves and craft a fiscally responsible system that works for all Granite Staters and does not ask us to subsidize the health care costs of other states."
