NH DMV No Longer Charging Fees for Disability Parking Placards



Know your rights! Individuals with walking disabilities cannot be charged a fee for removable disability parking placards. Charging a fee for parking placards violates the Americans with Disabilities Act (ADA). The NH Department of Motor Vehicles has now stopped charging fees for disability placards. A fair and accurate decennial census is crucial for people with disabilities—and,

indeed, for every person in the United States.

Your responses to the 2020 Census will help determine how many seats in Congress each U.S. state will receive, influence where the boundaries of

legislative, school, and

voting districts are drawn, and guide the allocation of \$1.5 trillion federal funds.
