HB 1486 - Adopting Remote Testimony Technology

HB 1486 is a bill that's likely coming to the House floor any day now. As amended, HB 1486 would create a committee to look into the Legislature's use of information technology for remote testimony to legislative hearings from locations closer to home.

We know how difficult it can be for people to get to Concord to testify on bills that matter to them. Adopting this technology would allow legislators to hear from stakeholders who can't be there in person to testify.

Several other states have addressed this by enacting systems that enable constituents to submit testimony through video conferencing technology from local community colleges or other local facilities. Under HB 1486, this committee would look into whether such systems could work here in New Hampshire. This is an important step in ensuring that constituents are able to fully take part in the

legislative process and advocate on bills that directly impact their lives.

We encourage you to contact your legislator and express your support for HB 1486 to ensure that our legislators can hear from all those affected by future proposed legislation.
