WHEN A CONDOMINIUM collapsed in Florida in June of this year, tragically killing 98 people, evidence of structural defects, reports of overdue repairs, and emails between owners, contractors, and city officials surfaced, all pointing fingers and demanding answers to the question "Could this have been prevented?"



Too many disasters, natural or manmade, are followed by reactionary tales of reform and the bemoaning of missed opportunities, whether intentionally or unintentionally ignored, that might have avoided the looming disaster.

New Hampshire's long-term care system is such a condo waiting to collapse, whether that care is delivered by a nursing home, home health,

or through community-based services, such as those for adults with developmental disabilities or acquired brain disorders. (read more)

To help you begin to understand some of the resources your family may want to consider as they develop a financial plan, The Arc's Center for Future Planning has developed a series of new videos.


