The Bureau of Developmental Service recently announced a period of public comment regarding proposed amendments to the Home and Community-Based Services, Section 1915(c), Developmental Disabilities, Acquired Brain Disorder, and In-Home Supports Waivers.

Please share this information with anyone that these potential changes may impact.

These amendments include:

- Updated language regarding compliance with federal regulations related to Conflict Free Case Management and Direct Billing requirements
- Updated language surrounding the ability to bill via the Organized Health Care Delivery System (OHCDS) for certain services
- Updated language regarding the cost of care
