Brain and Spinal Cord Injury Advisory Council Public Hearing

The Brain and Spinal Cord Injury Advisory Council (The "Advisory Council") is charged by the New Hampshire Legislature with investigating the unmet needs of New



Hampshire residents with brain or spinal cord injuries. See NHRSA 137-K.

The Advisory Council has been holding public hearings for twenty-five years, since its establishment by statute in 1997. The information provided at the hearing will be submitted in a report to Governor Sununu and the Legislature in order to provide recommendations to better meet those needs.

The next public hearing is scheduled on Tuesday, October 3rd from 6:00 pm - 7:30 pm at the K.B.I.C. Community Campus in Portsmouth. Online Registration Required - see registration link below. Pizza will be provided.

Survivors, family members, caregivers, friends and service agencies are encouraged to attend this Public Hearing to provide personal and professional input for unmet needs for individuals living with a brain injury or spinal cord injury.

CtLC Steering Committee Shared Competencies Survey

The CtLC (Charting the LifeCourse) Community of Practice group, made up of the Bureau of Developmental Disabilities, Bureau of Elderly and Adult Services, Bureau of Family Centered Services, and the Bureau of Behavioral Health, is working to create shared competencies regarding person centered practices.
