Legislative Outreach Needed on Recreational Activities Bill!

There is a new amendment to HB 1593, which makes an appropriation to the Department of Health and Human Services to support recreational activities for individuals with developmental disabilities.

This amendment sets up a temporary program to restore and, in some cases, maintain recreation funding for those served under one of the three developmental services Medicaid waivers. The long-term plan is to seek permanent recreation funds in next



state budget. However, this new amendment will lay the groundwork for future budget advocacy on this issue.

Senate Passes Down Syndrome Insurance Bill

Below is the committee report on SB 353, the vote in the Senate Health and Human Services committee was 5 to 0. The full Senate will take up this recommendation on Thursday, February 8th.

SB 353-FN clarifies insurance coverage for autism spectrum disorder and Down syndrome pursuant to RSA 417-E. The Committee heard very compelling testimony about the real-world impact that applied behavioral analysis (ABA) has on individuals and families. ABA helps many people develop the skills needed to live full, healthy, vibrant lives as productive members of society and there is evidence that ABA is effective for people with Down syndrome. The Committee also believes that there is merit in having a conversation about expanding SB 353-FN to apply to all developmental disabilities, rather than just being limited to autism and Down syndrome and hopes the bill will be sent to the Finance Committee so that conversation can take place.
