## **NH Senate Budget**

**Committee of Conference** 

Last Thursday, the NH Senate approved its version of the NH State Budget.

Starting with the budget proposed by the NH House, the NH Senate budget proposal restores funding to the waitlist, eliminates the 3% Medicaid Rates cut, and allows DHHS to retain \$10m in carry forward dollars to fund subsidies for housing stability (Room and Board). These are all positive for our space.

At the same time, however, the NH Senate budget proposal adds an additional \$5m to the \$46m back of the budget cut to DHHS for a total cut of \$51m over the biennium. Note that for back of the budget cuts, legislators only determine the amount; where the cut is applied is left to the department to decide.

As expected, the NH House did not concur with the NH Senate budget proposal. To address this, Senator Sharon Carson (Senate President), and Representative Sherman Packard (House Speaker) have appointed the following legislators to a Committee of Conference to work out a budget compromise:
